



Media Accreditation Rules

1. The organisation responsible for the accreditation process and issuing of thereof is the Organiser of the 18th International Jan Edmund Jurkowski Memorial Guitar Competition - the Municipal Culture Centre in Tychy, with the registered office at 26 Bohaterów Warszawy, 43-100 Tychy, Poland, entered in Cultural Institutions Register (RIK) of the City of Tychy under number 5.
2. Completion of the Media Accreditation Form available online at www.guitar.tychy.pl and selection of the festival events in which one wants to participate are prerequisite for processing of the application.
3. Submission of an application shall not be tantamount to obtaining accreditation.
4. Applications will be accepted until 3rd October 2022. Late applications will not be considered.
5. The information on granting accreditation and on how to collect it will be sent by e-mail to the address specified in the form no later than 10th October 2022.
6. The granted press accreditation must be confirmed by electronic means no later than 13th October 2022.
7. Detailed rules for the accredited journalists will be sent by e-mail before the start of the festival.
8. Accreditation is free of charge.
9. The number of accreditations is limited - there are a maximum of 2 accreditations per editorial office (of any kind).
10. The Organiser reserves the right to refuse accreditation without giving a reason, and to change the rules of granting accreditation.
11. The Organiser reserves the right to grant accreditation only for selected days and concerts.
12. In case of violation of the granted accreditation usage, the Organiser has the right to withdraw the accreditation.
13. Media which have priority in granting accreditation: sponsored media, media with greater coverage and circulation, media declaring an increased number of activities in the context of promoting and announcing the Silesian Guitar Autumn, and the media cooperating in the promotion of previous editions of the festival.
14. Accredited media representatives have access to designated zones made available to the media for the performance of journalistic duties, including (if so requested) the conduct of interviews.
15. Accredited media representatives are aware of the ban on photographing and video recording of concert auditions and major concerts - if you are interested in the materials, please check the appropriate option in the accreditation form.
16. The photographic materials from the events of the Silesian Guitar Autumn Festival provided by the Organiser can only be used in the context of the festival reports, in particular, they cannot be used for commercial purposes.



17. The Festival Organiser is not responsible for the accommodation of accredited media representatives, nor does it finance their stay and transport.
18. Accredited media representatives undertake to comply with all the rules and regulations, and to adhere to the recommendations of the organisers, as well as to the current epidemiological policies.
19. Within 30 days from the end of the festival, the accredited media are obliged to send all the materials that were created during and in connection with the Silesian Guitar Autumn Festival - in paper or electronic form (acceptable: PDF documents, scans, screenshots and direct links to published materials) - to the address contact@guitar.tychy.pl.
This does not result in the transfer of copyright ownership of the above materials to the Organiser.
20. Personal data of accreditation applicants will be processed in accordance with the provisions of the Privacy Policy ([link](#)).
21. Submission of an Media Accreditation Form is tantamount to accepting above regulations.
